1. Learner's Permit Stage (15-16) - (Hold for 12 months)

- : Permit issued when supervised by licensed adult
- : Violation/Collision free (6 months)
- : Safety belts worn by all occupants
- : Practice driving required with parents (Suggested)

2. Intermediate License Stage

- : Completion of driver's education program
- : Supervised driving continued (Suggested)
- : Seat belts worn by all occupants
- : Restricted late night driving (5:00 am - 10:00 pm)
- : Limited number of passengers
- : Violation/Collision free (6 months - can "re-set")
- : Increased penalties

3. Full-Privilege License Stage

- : Successfully complete Intermediate License Stage
- : Complete advanced driver's ed (Some states)
